Contents of the report:

The Management Board of Kino Polska TV S.A. announces that today, i.e. on August 23, 2013 it received a notification pursuant to Art. 69 sec. 1 point 1 of the Act on public offering, conditions of introducing financial instruments to organised trading, and on public companies, containing the following information:

"Pioneer Pekao Investment Management SA (PPIM), performing the service contract in the management of the investment fund portfolio, between **Pioneer Pekao Towarzystwo Funduszy Inwestycyjnych SA** and PPIM, and acting in accordance with Art. 69 sec. 1 point 1 of the Act as of July 29, 2005 on public offering, conditions of introducing financial instruments to organised trading, and on public companies [Journal of Laws 2009 No. 185, item. 1439, with later amendments], announces, on behalf of **Pioneer Fundusz Inwestycyjny Otwarty**, about an **increase** in the fund to the level of **5.06%** of the total number of votes at the General Shareholders Meeting of the company: **Kino Polska TV SA** for shares included in the fund's portfolio managed within PPIM's management services of the fund's investment portfolio.
